What is W3C ?



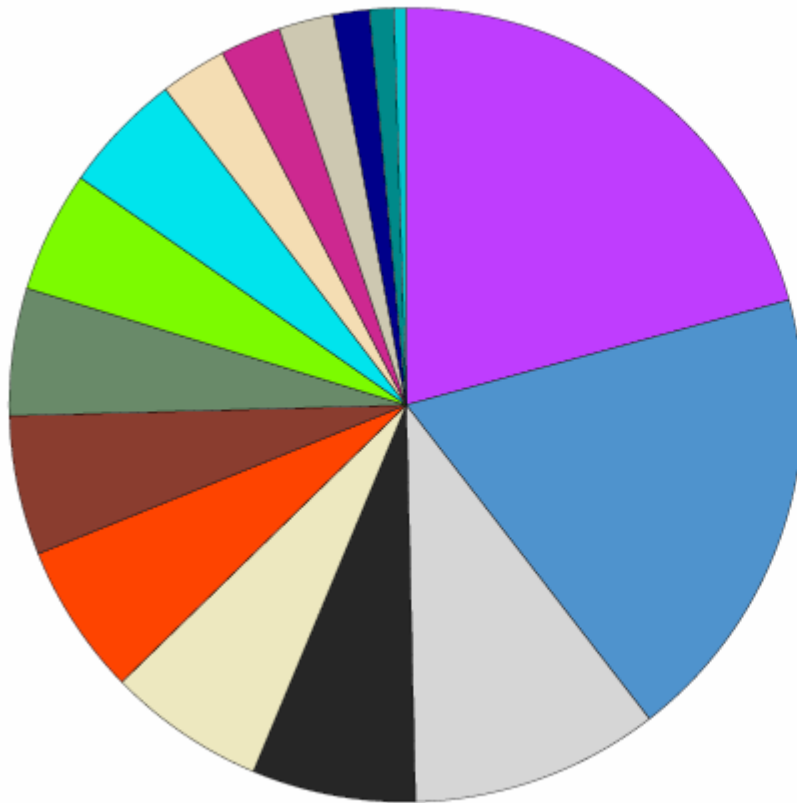
- The World Wide Web Consortium was formed in 1994 by Tim Berners-Lee to harmonize commercial developments of the Web.
- Not for profit, formal process, patent policy
- Over 350 member organisations – big & small, developer & user, in Americas, Europe and Asia
- W3C develops recommendations for technologies to use on the Web.
- Recommendations are developed by working groups of members – about 3 years from creation to recommendation
- W3C is leading the Web to its full potential.

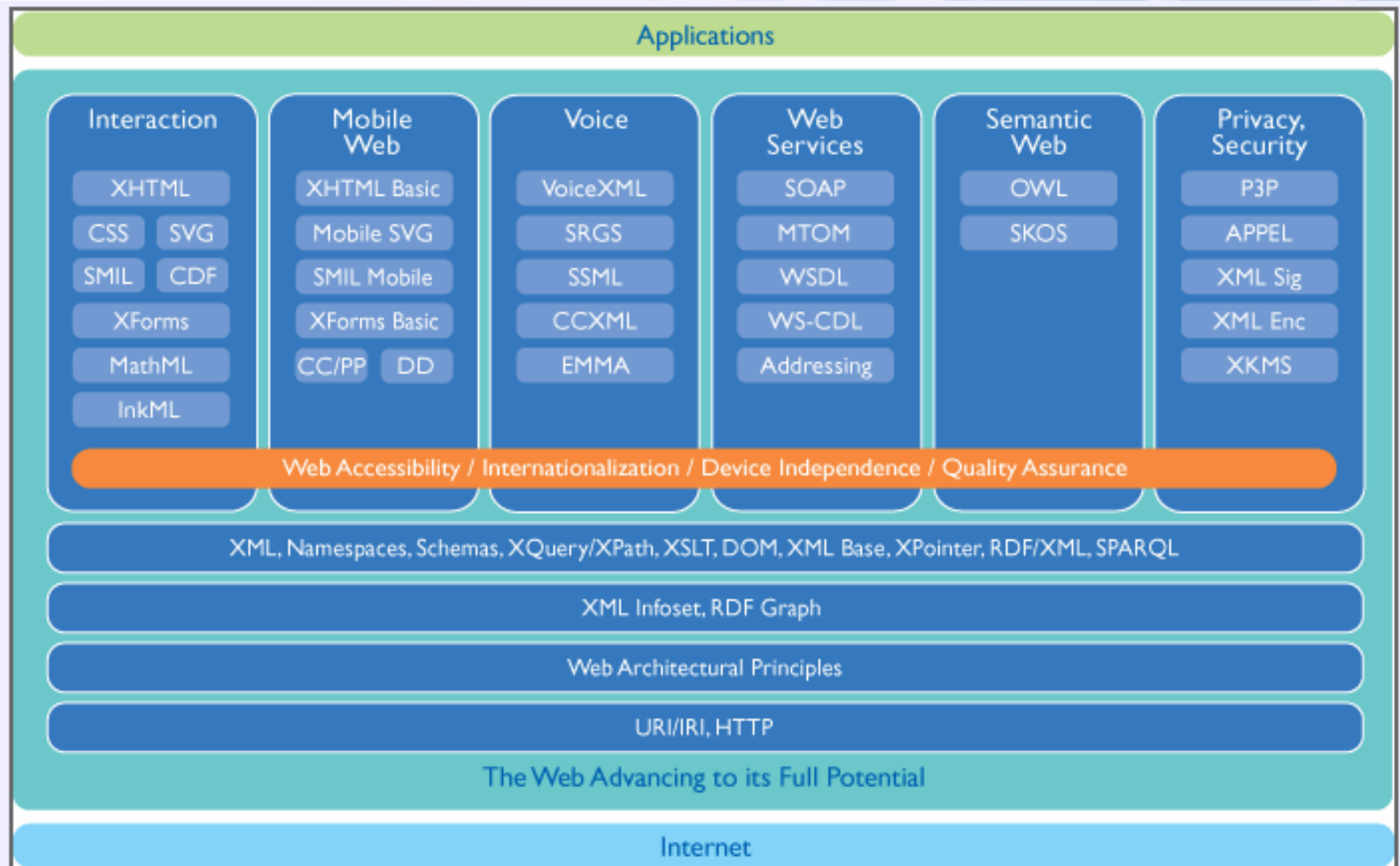

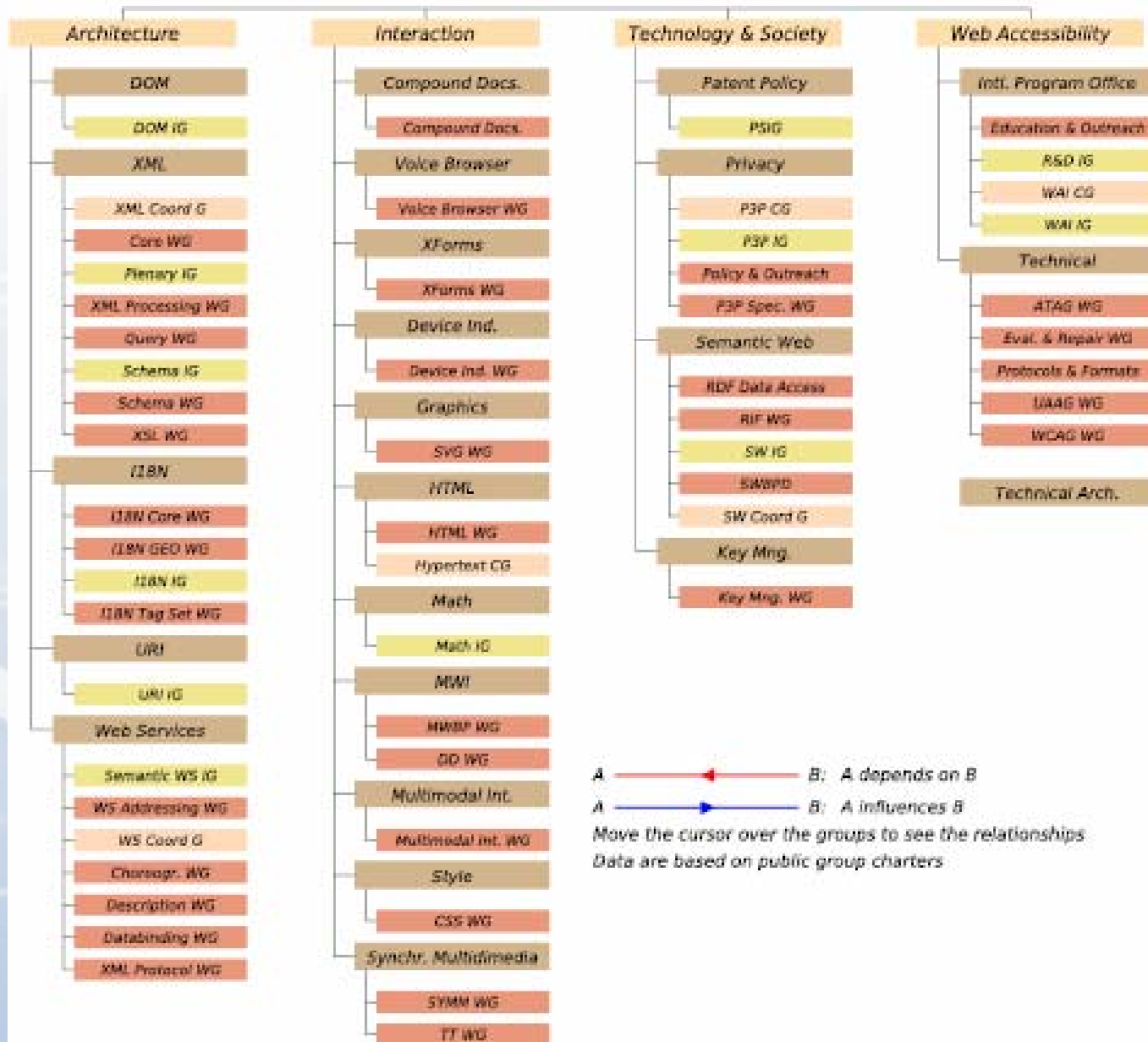
What W3C has done
