- What else needs to be done to encourage open innovation in Europe?

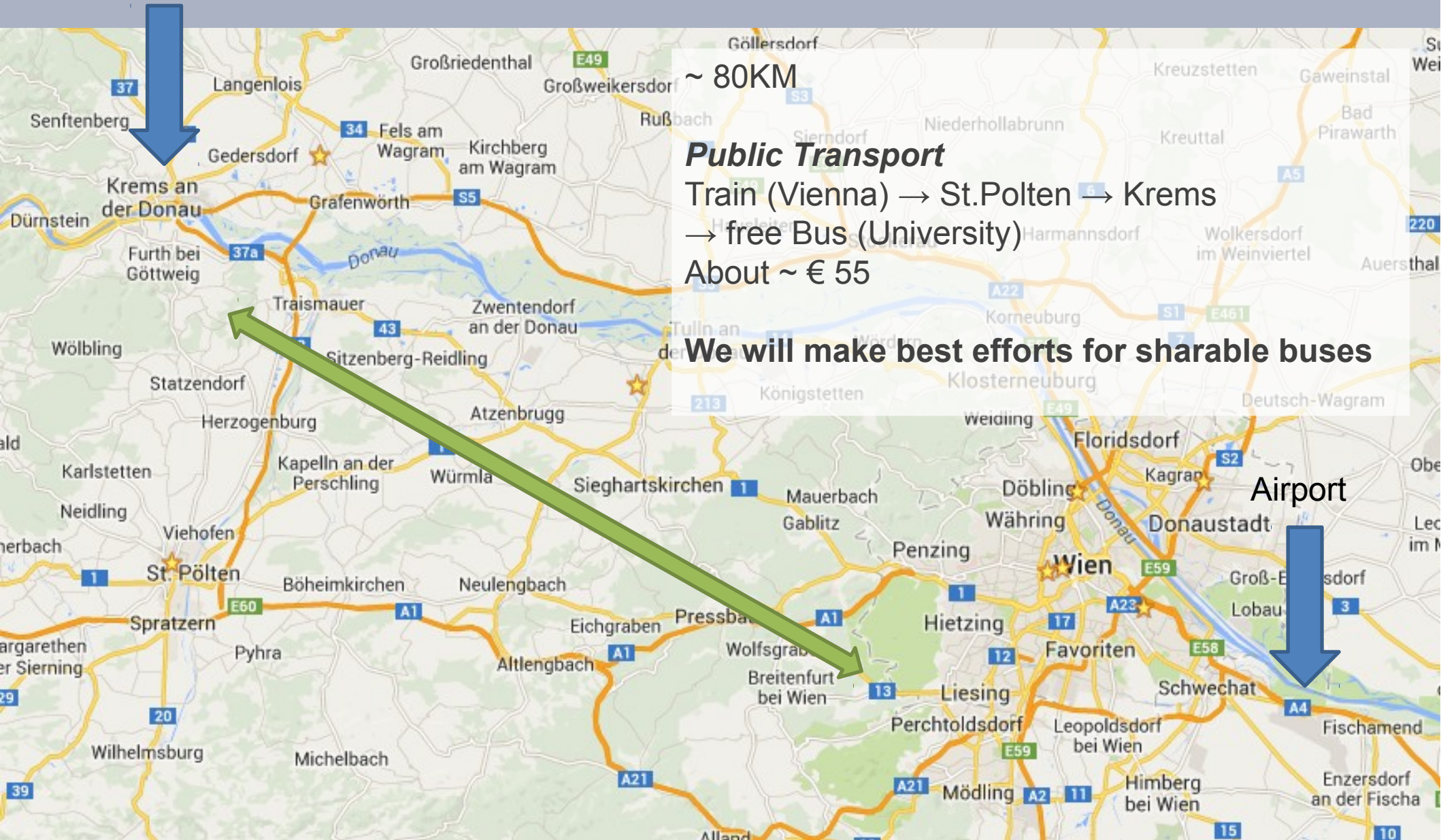

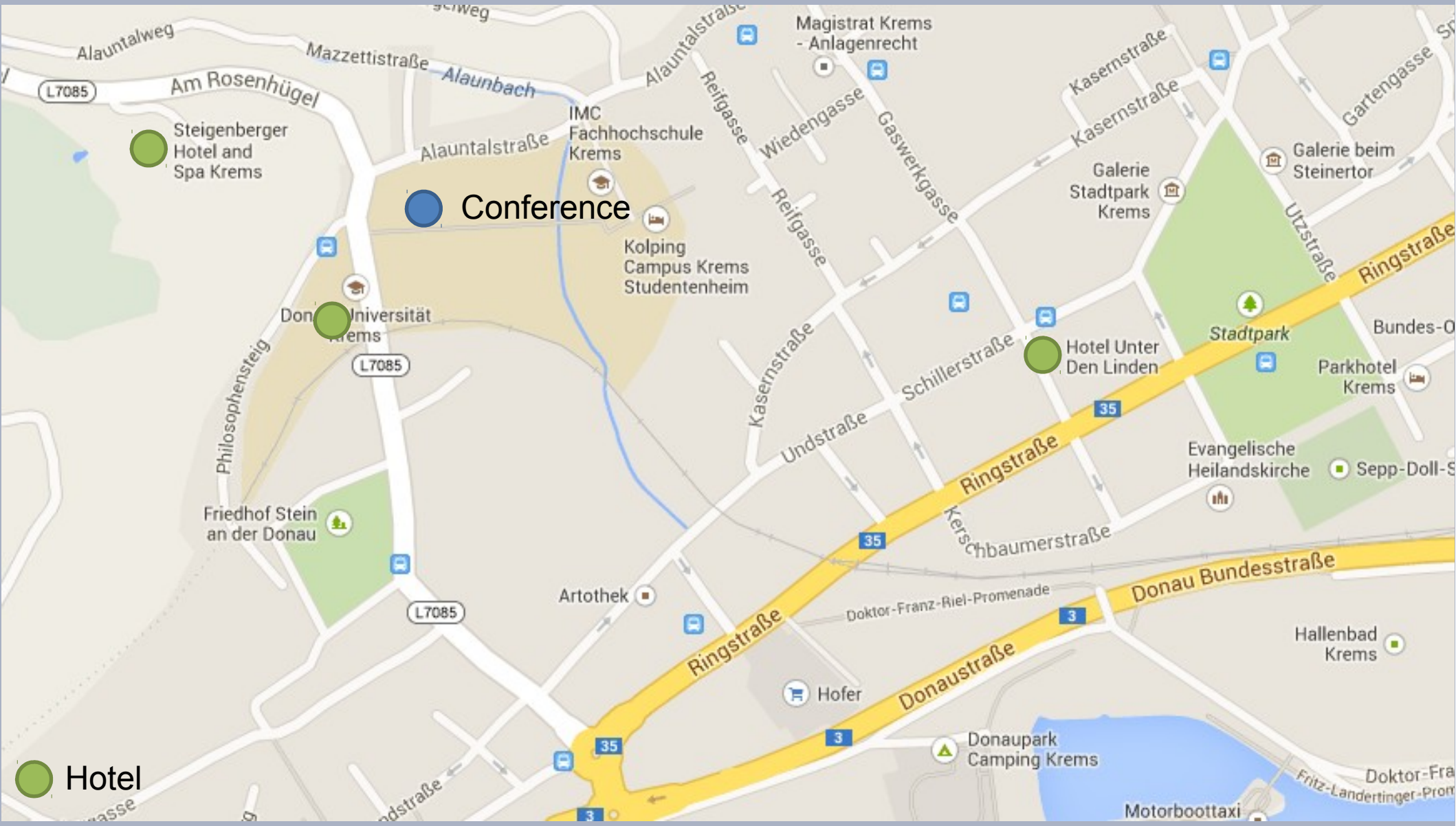
